**Order.**

**12.08.2018.**

By an order dated 31.07.2018 was directed the Officer in-charge, Patuakhali Police Station, Patuakhali and Mr. Jahangir Howlader, Advocate, son of Abdul Khaleque Howlader, the informant of Patuakhali Police Station Case No. 02 dated 01.04.2018 to appear before this Court in person on 12.08.2018 at 10.30 am without fail to explain why they have violated the direction of this Court given on 11.04.2017 in Criminal Miscellaneous Case No. 11261 of 2017.

Today at 10.30 am both of them are found present in this Court.

By filing an application Mr. Nazmul Hasan Rakib, the learned advocate for Mr. Jahangir Howlader begs sincere and unconditional apology for his unintentional mistake and he will never use nickname of any persons which has not been given from his family. In the circumstances, we are inclined to allow the application, Thus, the same is allowed.

The personal appearance of Mr. Jahangir Howlader is hereby dispensed with and he is exonerated from the charge. However, Mr. Jahangir Howlader, an Advocate of the Patuakhali District Bar, Patuakhali is cautioned to be more careful in future in dealing with such kinds of matters in using the name of a person.

Another application has been filed by Mr. S.M. Rezaul Karim, learned advocate for Mr. Khandaker Mustafizur Rahman, Officer-in-Charge of Patuakhali Sadar Police Station, Patuakhali wherein he stated that he received the petition of complaint from the Court of Chief Judicial Magistrate, Patuakhali to treat the said petition of complaint as First Information Report. After receiving the same when he investigated the case and filed the report he deleted the nicknames of the accused persons. We asked him whether he has any knowledge of the order dated 11.04.2017 passed in Criminal Miscellaneous Case No. 11261 of 2017, he answered in affirmative.

Accordingly, the personal appearance of Mr. Khandaker Mustafizur Rahman, Officer-in-Charge of Patuakhali Sadar Police Station, Patuakhali is dispensed with and he is exonerated from the charge. We appreciate him for doing a proper job in deleting the nicknames of the accused persons from the charge sheet which were not given from the family of the accused persons.

However, the learned Chief Judicial Magistrate, Patuakhali is hereby cautioned not to entertain any petition of complaint in which the nickname of the accused has been used which was not given from his family and apparently it (nickname) undermines and humiliates the social dignity of the accused person.

The office is directed to communicate a copy of this order along with a copy of the order dated 11.04.2017 passed in Criminal Miscellaneous Case No. 11261 of 2017 to the Secretary, Ministry of Law, Justice and Parliamentary Affairs and the Registrar General of Bangladesh Supreme Court so that they can ask all the Chief Judicial Magistrates not to receive any kind of petition of complaint in which the nicknames of the accused has been used which was not given from his family and apparently it undermines and humiliates the social dignity of the accused person, by fax as well as in the usual course immediately.

**11.04.2017.**

In pursuance of the order dated 28.03.2017 the Officer in Charge, Kadamtoli Police Station, Dhaka has produced Md. Jahangir Alam, son of late Sabdor Ali before this Court.

Mr. Asif Ahmed Murad, the learned advocate with the permission of the Court appearing on behalf of Md. Jahangir Alam submits that the accused persons are known in the locality by the said names. However, he apologized for using such nicknames which are not given from the family of the accused persons.

We have seen in many cases some of the informant use this kind of nicknames of the accused and the police register the case with such nicknames. It is very unfortunate to accept this kind of activity. we are herby directing all the Superintendent of Police and the Officers in Charge of the Police Stations of the country not to register any case with the nicknames of the accused persons which are not given from his family and humiliate the social dignity of the accused.

The Senior Secretary of the Ministry of Home Affairs and the Inspector General of Police (IGP) are hereby directed to take immediate step so that the Officers in Charge of the Police Stations do not receive any kind of First Information Report (FIR) in which the nicknames of the accused persons has been used which has not been given from his family and it humiliates the social dignity of the accused.


Md. Md. Jahangir Alam is directed to file an application before the concerned police station to delete the nicknames used by him against the accused persons within 7(seven) days from date.
